January 20th

MINUTE 2020.01.1: FMSA commits to making lunches for migrants passing through the bus station for the third Tuesday of each month with David Hayes coordinating and paid for from the Immigrant Aid Fund in the amount of \$1500.00 for the year. APPROVED

MINUTE 2020.02.01: FMSA approves holding the 6th Annual Quaker Day Fair on Saturday, May 2nd , as outlined in the February committee report. APPROVED.

MINUTE 2020.02.02: Meeting approves donating the money earned to 3 organizations chosen by P&SC. APPROVED.

MINUTE 2020.4.3: In response to the COVID-19-related suspension of in-person Meetings, FMSA approves continuing to pay our childcare worker's monthly salary for Sundays. APPROVED.
